

## 2025 100K BELTED PURSE

### OFFICIAL RULES

*Gates Corporation's 2025 100K Belted Purse is a contest for a grand total €100,000 prize. Cycling teams with team members competing in Elite division races of the UCI World Cup Downhill while using Gates CDX belts on their bikes are eligible to win. The prize will be awarded to the first cycling team with an eligible team member entered in the contest to win a race. The prize will not be awarded unless an eligible team member wins a UCI World Cup Downhill race. This summary is subject to the Official Rules set forth below.*

**1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.**

2. **ELIGIBILITY:** Open only to cycling teams with team members who are: (i) 18 years of age and older, (ii) entered in the "Elite" Division of any Union Cycliste Internationale (UCI) World Cup Downhill races in 2025 (each, a "**Competition**"), and (iii) compete in a Competition with a bicycle using a Gates CDX belt as the sole transmission of power through the bicycle's drivetrain. Any team member who meets the criteria set forth in (i) through (iii) above and who has been entered into this Contest in accordance with Section 3 below is an "**Participant**" under these Rules. A cycling team with at least one Participant is an "**Entrant**" under these Rules. Void where prohibited.

3. **HOW TO ENTER:** Beginning on April 22, 2025 at 9:00AM MST through October 4, 2025 at 9:00AM MST, eligible cycling teams or their team members can log on to [www.gatescarbondrive.com/products/100k-belted-purse](http://www.gatescarbondrive.com/products/100k-belted-purse) for the 100K Belted Purse contest entry form and follow the on-screen entry instructions for entering eligible team members. All required information on the entry form must be completed. Entries for team members must be submitted no later than 72 hours before the start of any Competition. Entrant must notify Gates Corporation ("**Sponsor**") if at any time a Participant no longer meets the eligibility requirements. Sponsor reserves the right to extend or shorten the entry period at any time in its sole discretion. Sponsor reserves the right to cancel, terminate, modify, or suspend the contest in its sole discretion. Sponsor reserves the right to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the contest.

4. **JUDGING CRITERIA:** The Entrant with the first Participant to win a Competition (the "**Race Winner**"), as determined by the Competition rules and officials, is deemed the winner of the contest. If multiple Entrants win a Competition simultaneously, each is deemed a winner, and the prize will be divided evenly among the winners. **EACH ENTRANT ACKNOWLEDGES AND AGREES THAT IF NO ENTRANT WINS ANY COMPETITION, THEN THE CONTEST WILL TERMINATE, AND THE PRIZE WILL NOT BE AWARDED.** The winner(s) will be notified by email or phone and must sign and return any required Affidavit of Eligibility and Release and Sponsorship Agreement within 30 days of the date notice is sent or such other date set by Sponsor. Failure to respond within the applicable time period will result in forfeiture of prize.
